Corporate Real Estate

Our Retail Conveyancing team advises and acts for private individuals, corporate investors, banks, financial institutions and statutory boards, in transactions involving residential property.

Our Retail Conveyancing Work Includes:

- acting for vendors, purchasers and financiers in the sale, purchase, and financing of residential private properties;
- acting for co-owners of a property in their de-coupling and fractional transfers;
- representing landlords, tenants, in residential tenancies which include negotiation of the terms and conditions;
- representing borrowers, mortgagees as well as the Central Provident Fund Board (CPF Board) in residential property financing transactions;
- acting in the refinancing and redemption of housing or term loans secured by a residential property; and
- advising on general residential property-related regulatory matters.
